

PRIVACY POLICY NOTICE

Privacy Policy Notice

In compliance with the Gramm-Leach-Bliley (GLBA) Act and the United States Securities and Exchange Commission (SEC), this notice describes the privacy policy and practices followed by Blue Duck Wealth Management, Inc. Non-public Information Collected.

- Information we receive from you on applications or other forms such as your name, address, date and location of birth, marital status, sex, social security number, medical information, beneficiary information, etc., and
- Information about your transactions with us, our affiliates or others such as premium payment history, tax information, investment information, and accounting information.

Non-public Information Disclosed.

- We may provide the non-public information that we collect to affiliated or non-affiliated persons or entities involved in the underwriting, processing, and servicing of your accounts with Blue Duck Wealth Management Inc. We will not provide this information to any other non-affiliated third party unless we have a written agreement that requires such third party to protect the confidentiality of this information.
- We may have to provide the above described non-public information that we collect to authorized persons or entities to comply with a subpoena or summons by federal, state or local authorities and to respond to judicial process or regulatory authorities having jurisdiction over our company for examination, compliance or other purposes as required by law.
- We do not disclose any non-public personal information about our customers to anyone except as permitted or required by law.
- We may disclose the information above Blue Duck Wealth Management, Inc. as we are affiliated through common control and ownership.

Confidentiality and Security of Your Non-public Personal Information.

- We restrict access of non-public personal information about you to only those persons who need to know about the information to process and service your accounts with Blue Duck Wealth Management, Inc.
- We maintain physical, electronic, and procedural safeguards that comply with state and federal standards to guard your non-public personal information.
- If we become aware at any time that personal information may be materially inaccurate, we will make a reasonable effort to re-verify its accuracy and correct any error as appropriate.
